Social Networking and Giving Platform Terms of Use

Welcome to Bermuda Community Foundation's GiveBermuda.org Forum, an online giving platform in Bermuda. To provide a comfortable and respectful space for all, a place that fosters philanthropy and charitability, we have developed guidelines for posting and conduct. Please read them closely. Failing to comply with the following Terms of Use may lead to the deletion of posts, personal warnings, and possible denial of access.

Terms of Use

These Terms of Use ("Terms of Use") provide important information about your use of the discussions forums on the www.GiveBermuda.org website (the "Platform").

Your use of the Platform is subject to these Terms of Use. By accessing, viewing, or contributing to any of the Platform, you agree to be bound by, and use the Platform in compliance with, these Terms of Use. IF YOU DO NOT AGREE TO THESE TERMS OF USE, DO NOT USE THE PLATFORM.

IMPORTANT: IF YOU USE THE PLATFORM, YOU MUST ACCEPT THESE TERMS OF USE AS PRESENTED TO YOU HERE, WITHOUT CHANGES, ADDITIONS, OR DELETIONS. At any time Bermuda Community Foundation may change, add, or remove any part of these Terms of Use or any part of the services and features provided in the Platform. General
